Developing SKIIS needs partnerships

The state of employment equity, skills development (\$kills trasnfer) and training of black people. Upward mobility of black people. What are the numbers like in the various sectors? What a research has been done? — Jinimy Manyi

IN THE LONG TERM, GOVERNMENT NEEDS TO change the educational curriculum in such a way that, from the early stages of education, it begins to respond to skills needed by the economy. In the

short term, the private sector needs to counsel the gatekeepers for attitudinal preparedness in order to embrace employment equity and skills development

as critical to sustainable economic growth.

While our new democracy has ensured that we benefit from laws aimed at redressing the imbalances of the past, such as Broad-Based Black Economic Empowerment and the Employment Equity Act, there are

still incidents of racial discrimination in the workplace and within our society in general.

The relevance of the Black Management Forum (BMF) is to ensure and monitor the implementation of such policies so that blacks, women and people with disabilities are advanced in the workplace and that real transformation does indeed take place.

The Irish coffee scenario

The 2006 report of the Commission for Employment Equity (CEE) says, what is even more worrying than the disproportionate representation of whites at top management level is that corrective processes such as recruitment and promotions continue to reinforce the status quo. There



seems to be inherent racist stereotyping and ingrained mistrust of black people's capabilities when it comes to opening up opportunities in top management.

This is evidenced by the almost doubling in numbers of white women in senior and top management. Which begs the question: if they were as disadvantaged as they are purported to be, what has suddenly given them the competitive edge over black people?

There is still what the BMF has always called the Irish coffee scenario: whites dominate the top management level, with just a sprinkle of black executives at the top. The lower levels of the workforce, as in a typical Irish coffee cup, are predominantly black.

Each of these layers faces its own unique challenge as far as employment equity, skills development and transfers are concerned.

Proof of capability

At top management level, black executives have to work 10 times harder than their white counterparts in order to prove they are capable.

They are expected to perform miracles, and only then are they seen as being capable of running operations and given appropriate recognition. Even those who are occupying these higher levels of management are mostly placed in support areas of the organisations - like corporate communications, human resources and government liaison, and not core to the business operations. If we were to agree to this way of thinking, it would mean black people would never be given the opportunity to show their potential because they will never have the appropriate experience in line functions.

If the current orthodox way of thinking (prerequisite experience - eupinemism for artificial barriers) had prevailed in the embryonic stages of our democracy, then great statesmen like Nelson Mandela, arguably the best Reserve Bank Governor, Tito Mboweni, and the darling of the markets, Trevor Manuel, would have needed 10 years of exposure in their respective areas. But their track record has shown that they excelled beyond the wildest

expectations of even the most optimistic.

How many other potential leaders are we denying the opportunity to shine because of the artificial barriers put up by corporates?

Fast-tracking transformation

There must be strategies in place to fasttrack transformation and incrementally expose more black executives to the running of operations. Not enough effort is made by corporates on the setting of career paths and providing the necessary support mechanisms for the clear purpose of grooming blacks ultimately to run these operations.

It is also true that development of black people is an inherent threat to existing white executives. The readiness of blacks could be seen to mean that the white executives are no longer needed.

Therefore, we need to devise ways of positive recognition for those white people who play the mentorship role in order to encourage more whites to transfer skills effectively. Perhaps this could be through policies that encourage the deployment of white executives to

play non-executive roles in developing black SMMEs.

The "what" rather than the "why" The challenge facing the lower levels, however, is different, and is dominated by poor skilling and a totally flawed approach

to skills transfer.

People at lower levels are taught the "what" rather than the "why". And because of this approach, they never rise to the occasion because they lack an analytical approach to problem solving, and are likely to wait for further instruction from the supervisor when creativity and innovation are needed. As a result of this approach, the majority of our labour force remains unskilled. Despite the fact that there are black people with over 20 years of working life, no holistic skills transfer has occurred.

Private-sector involvement

Corporate South Africa needs to take a quantum leap in thinking in order to liberate our economy.

For black people, training has gradually become a stigma when it should be something to look forward to. It is largely

being used by corporates as a deliberate delaying tactic.

Black people have traversed all the business schools locally and overseas, their CVs have endless lists of short courses. Having said that, training and proper skills transfer are needed largely in the more technical environment at both the high and lower levels of the workforce.

While we welcome the import of professionals to address the dearth of priority skills, as is the case of welders being brought in by Sasol, we wait in anticipation to see the skills that these expatriates will be able to transfer to the local workforce at the end of their contract period.

A new approach to education


There is a need to collect data so that we are able to monitor the effectiveness of such strategies. We sit with a problem in that a lot of available labour force research is flawed because it is focused on formal qualifications. There is a reason why the definition of a suitably qualified person in terms of the Employment Equity Act is in four parts,

namely formal qualification, recognition of prior learning, previous experience and the potential to excel given the necessary support base.

We need to develop a matrix that links qualifications to skills. This would help address the fundamental challenge of unemployed graduates due to skills mismatch. Is there no way that, as a short-term strategy, these young graduates can be reoriented to the job market through on-the-job reskilling and apprenticeships? The problem of under-utilisation of current skills is much bigger than a complete lack of skills.

Of course, we realise that, in the long term, government needs to change the curriculum so that from the early stages of education it begins to respond to skills needed by the economy. But corporates have a role to play in the short term. They need to counsel the gatekeepers for attitudinal preparedness in order to embrace employment equity and skills development as critical to sustainable economic growth.


